There are many ways to leave your mark on the world. Your relationships with your whānau (family) and friends, your work, community engagement and more all contribute to memories of you.

Another way is to leave a planned gift to the Cancer Society in your will. By doing so, your kindness will live on, improving lives long after you have gone. When you support us, you become a partner in helping to reduce the incidence and impact of cancer affecting our communities.

Your planned gift could include:

- A percentage (or whole) of your estate
- A sum of money
- Property
- Stocks and shares
- A life insurance policy

## Your gift could help us with...

### **Support and Information**

Cancer Society Nelson Tasman offer emotional, social, and financial help for people affected by cancer. Our frontline services include:

- Volunteer driving service.
- Specialised counselling for people affected by cancer and their whānau.
- Support groups and workshops
- Yoga classes and gym programme
- Hardship support grants
- Volunteer Visitor Programme
- Cancer information and resources
- Advocacy and support in navigating health services
- Support for whānau with tamariki; Library including children's library
- Linking in with other cancer community and iwi services
- Kia ora - E te Iwi - Kaupapa Māori Cancer Education resource
- Expert Cancer Information Nurses who provide advice in-person, via phone or email.

### **Accommodation away from home**

A 'home away from home' for cancer patients who need a place to stay while receiving treatment outside the region. This greatly reduces the financial burden on patients and their families.

## **Research**

The Cancer Society is a major funder of life-saving and world-class cancer research through our Research Grants Programme, dedicated to finding ways to reduce, treat or eradicate cancer.

## **Health Promotion**

We work with community groups to create and provide a range of resources to help people make healthy lifestyle choices to reduce their risk of cancer.

## **Advocacy**

We advocate for equitable public health outcomes. This means we have strong relationships with the media to comment on public health issues such as tobacco control, skin cancer prevention and equitable access to cancer treatment and screening programmes.

## **Planning your gift**

Leaving a planned gift is a very personal decision. If you would like your gift to be used for a specific purpose, please get in touch.

There are many ways you can arrange to leave a gift to the Cancer Society Nelson Tasman in your will. Your solicitor, trustee or the Public Trust can assist with the detail, but in general, there are three main types of gifts:

- Residuary Gift – leaving a portion or the remainder of your estate to the Cancer Society Nelson Tasman after all other commitments have been honoured.
- Specific Gift – leaving a specific item, such as property or shares to the Cancer Society Nelson Tasman.
- Pecuniary Gift – a gift to the Cancer Society Nelson Tasman of a stated sum of money designated in your will.

## Preparing your will

Here is an example of the words you can use:

"I bequeath The Cancer Society Nelson (CC33976), the sum of \_\_\_\_\_ dollars [or a percentage of your residual estate], to be applied by the Cancer Society in such a manner as its Directors may determine [or for the purposes of \_\_\_\_\_]. I direct that a receipt from the Cancer Society shall be a good and sufficient discharge to my Executors."

## Receive \$250 towards your legal costs

Once you have made a gift to us through your will or a memorandum of wishes, you can arrange for your lawyer or the Public Trust to send us an account for up to \$250 plus GST towards the cost of your legal fees.

Please let us know if you have made a gift in your will, as this helps us plan for future projects, and allows us the opportunity to engage with you on the future use of your funds if you wish. Telling us your wishes is 100% confidential.

When you contact us, we will offer to make you a lifetime member of the Hope Fellowship – a small way for us to acknowledge your commitment and generosity.

You will then receive:

- A lapel pin to commemorate the promise of a gift in your will.
- The choice to have your name on the Hope Fellowship honours board located in our Newtown office reception.
- With your consent, a special mention in appropriate Cancer Society publications.

Joining the Hope Fellowship is completely up to you.

We understand that some supporters wish to remain anonymous. We will always respect the wishes of those who want to keep their gifts confidential.
